- ► BA<sup>3</sup> FIDELITY AZIONARIO GLOBALE RESEARCH

Their relevant features are described under the respective appendices.

Moreover, the Board of Directors decided to proceed with additional ancillary changes both to the prospectus' main section and to certain of its appendices, as further described below.

#### A. Amend the prospectus' main section as follows:

- Update section 2 "Management and Administration", to reflect changes at the level of the Board of Directors (Ms Laura MONOPOLI replacing Mr. Andrea PAPPINI) and at the management company's conducting officers (Mr. Alessandro D'ERCOLE now being responsible for the accounting and IT functions, Mr. Alessio TOGNOLI as responsible of the risk management function and Mr. Christian FOLZ as replacement for Mrs. Elisabeth BACKES and in charge of the investment management function);
- Update section 5.2 "Redemptions of Shares Procedure" specifying that redemption requests must solely state the number of shares, with the option to state the amount to be redeemed being removed in consideration of the fact that redemptions by amount are of no practical usage given that the relevant NAV is not available when investors provide redemption's instructions;
- Update section 9.1.2. "Sustainability Investment" in accordance with the entry into force of SFDR Level 2 provisions ("SFDR RTS") published on 27 July 2022 and including, *inter alia*, a disclosure on principal adverse impacts;
- Insertion of section 14.2.1 "Registrar and Transfer Agent, Paying Agent and Domiciliary Agent fees", section 14.2.2 "Depositary fees "and 14.2.3 "Distribution fees", replacing the previous sections 14.5, 14.6, 14.7 and making reference to the detailed fee information provided into the relevant sections of Appendix II -The Sub-funds".

- B. Amend "Appendix I List of Sub-Custodians" so as to capture the removal of RBC Investor & Treasury services;
- C. Amend the Appendix II "List of Available Sub-Fund(s)", so as to include the four new sub-funds being created.

#### D. Amend the Appendices related to the existing Sub-Funds so as to:

- 1. Replace the reference to the "Key Investor Information Document (KIID)" by a reference to "PRIIP Key Information Document (KID)" and amendment of the maintenance fee applicable thereof, triggered by the increased complexity and production cost of the latter;
- 2. Update the fee disclosure methodology, in accordance with the prevailing market practice, by introducing the concept of maximum fees applicable by the service providers (i) to provide for interim adjustments thereto linked to changes to the Luxembourg salaries' sliding scale index, and (ii) to include ancillary services of the service providers pursuant to the relevant services agreement (for details on the current applied fees and maximum floors the various service providers may go up to, please refer to Schedule 1);
- 3. Enhance transparency by providing Investment Management Fees detailed disclosures and, through the removal of the Sub-Investment Manager Fee section, clarifying that both the Investment Management Fees and the Sub-Investment Management Fees are paid out of the Investment Management fees (for each of the Sub-Funds' specifics, please refer to Schedule 2);
- 4. Other changes, Sub-Fund specific, as further detailed in Schedule 2.

The changes above mentioned will have immediate effect except the ones related to points A and D above, represented in certain amendments by additional/increased fees or changes in the investment policy above detailed, are subject to 30 days' notice period until 20 November 2023. During this notice period, the shareholder has the right to redeem the concerned shares free of charges.
