What is this product?

Type

The Sub-fund is part of BA³ STRATEGIC INVESTMENT SICAV fund. The Fund is an open-ended investment company with variable capital, incorporated in the Grand Duchy of Luxembourg. This Fund is authorised and supervised by the CSSF. The Depositary is Banque Havilland S.A.

Term

The investment horizon is medium term and should be at least 3 years.

Objectives

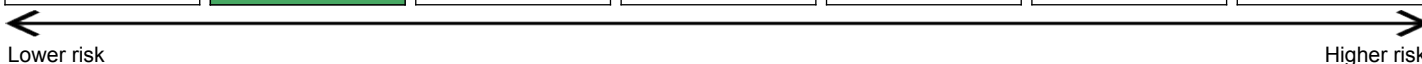
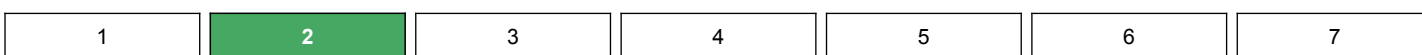
The Sub-Funds invest in fixed income and it is actively managed. The investment objective is to create value in line with the performance of the benchmark. "Obbligazionario" is linked to fixed income investment of the Sub-Funds, "attivo" is linked to the actively managed, "3" is about the focus to outperform the returns on time horizon of 3 years in euro.

Intended retail investor

Reserved for retail and institutional investors. This Sub-Fund is addressed to investors who intend to benefit from fixed income market trends while accepting the level of risk and volatility associated with the reference market. Minimum Subscription: 1.000 EUR.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product for 3 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund is not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable scenario: This type of scenario occurred for an investment between 14/10/2021 and 14/10/2022 (If you exit after 1 year), 06/03/2020 and 06/03/2023 (If you exit after 3 years).

Moderate scenario: This type of scenario occurred for an investment between 24/12/2014 and 24/12/2015 (If you exit after 1 year), 10/07/2015 and 12/07/2018 (If you exit after 3 years).

Favourable scenario: This type of scenario occurred for an investment between 11/03/2014 and 11/03/2015 (If you exit after 1 year), 20/09/2013 and 22/09/2016 (If you exit after 3 years).

What happens if Adepa Asset Management S.A. is unable to pay out?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 3.45 % before costs and 0.90 % after costs.

How long should I hold it and can I take money out early?

Recommended holding period: 3 years

This fund has no minimum holding period, but has been created for medium term investment. You should therefore be prepared to remain invested with your investment for at least 3 years. However, you can return your investment on any bank business day in Luxembourg.
