## What is this product?

### Type

The Sub-fund is part of BA<sup>3</sup> STRATEGIC INVESTMENT SICAV fund. The Fund is an open-ended investment company with variable capital, incorporated in the Grand Duchy of Luxembourg as a "Société Anonyme". This Fund is authorised and supervised in Luxembourg by the CSSF.

### Term

The investment horizon is medium term and should be at least 5 years.

### Objectives

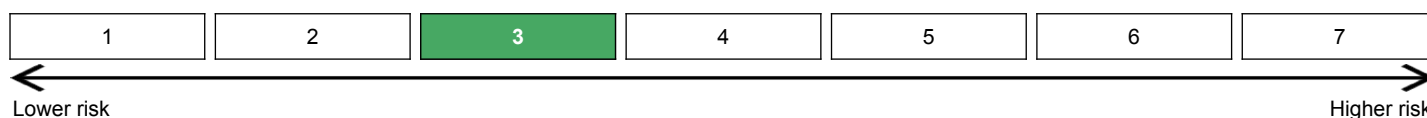
The Sub-Fund is actively managed. The objective of the Sub-Fund is to seek medium to long-term capital appreciation, with medium volatility. The Sub-Fund seeks to achieve its objective by investing indirectly through multi-strategy and multi-asset class approaches. Multi-strategy approach refers to the possibility to diversify the sources of alpha by investing in different kind of investment strategies, whereas multi-asset class approach refers to the possibility to invest in different type of asset classes (through single asset market UCIs and/or multi-asset UCIs) in order to diversify the underlying market risks.

### Intended retail investor

Reserved for retail and institutional investors. The investment strategy corresponds for the investors with a medium investment risk profile.

## What are the risks and what could I get in return?

### Risk Indicator:



The risk indicator assumes you keep the product until 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are very unlikely to impact our capacity to pay you.

## What happens if Adepa Asset Management S.A. is unable to pay out?

## What are the costs?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
